FORWORD

Baseline Survey in all Districts of Mizoram is one of the items approved in the DPR of the India Statistical Strengthening Project (ISSP). The matter was proposed to the Administrative Department in 2015 and the Government decided to conduct BPL Baseline Survey to bring out a rationalized BPL list of the State, as different Departments have different BPL list.

Mizoram Statistical Development Agency (MSDA) the implementing Agency of ISSP under the Directorate of Economics & Statistics proposed to the Government for Constituting 3 (three) committees such as State Level Monitoring Committee, under the Chairmanship of the Secretary Planning, District Level Monitoring Committee under the Chairmanship of the Deputy Commissioner and Village Level Monitoring Committee under the Chairmanship of Village/Local Council President/Chairman comprising seven members to identify all BPL families and to survey within their jurisdiction.

The first meeting of the State Level Monitoring Committee on BPL Baseline Survey decided to prepare the guidelines/criteria for the survey. As such the guideline/criteria were prepared from the Directorate of Economics & Statistics and submitted to the Administrative Department for approval. The State Government approved the criteria with certain modification in the context of Mizoram.

The approved criteria was circulated to all the Deputy Commissioners who is the Chairman of the District Level Monitoring Committee. The District Level Monitoring Committee engaged the Block Development Officers as supervisors who arranged training for the Chairman of the Village/local Council Monitoring Committee and circulated the criteria and formats to each Village Monitoring Committee.

The Village Monitoring Committee, by following the criteria finally identified all the BPL families in the village. Profile of each village is also incorporated in this publication.
